History of NCP

We were founded in 1931 as a small operation in West London

1931

Central Car Parks was formed in 1948 by Ronald Hobson and Donald Gosling who saw a need for parking spaces in the London area

1948

We were acquired by US firm Cendant. During this period, we re-focused our operations, shifting any form of property ownership to a more service orientated organisation

1990

The company changed its name to National Car Parks. NCP began to acquire a series of car parks, petrol stations and managing car parking contracts for third parties

1999

We were sold in 2002 to buyout firm Cinven

2002

We were sold to private equity house 3i which reflected the high level of interest in NCP's business

2005

NCP separated the original parking arm of the company National Car Parks Limited from the new service based side of the business National Car Parks Services LTD

2007

In 2017, Macquarie European Infrastructure Fund II (MEIF2) sold NCP to Park24, a listed Japanese strategic buyer and Development Bank of Japan Inc (DBJ), a Japanese government owned financial institution

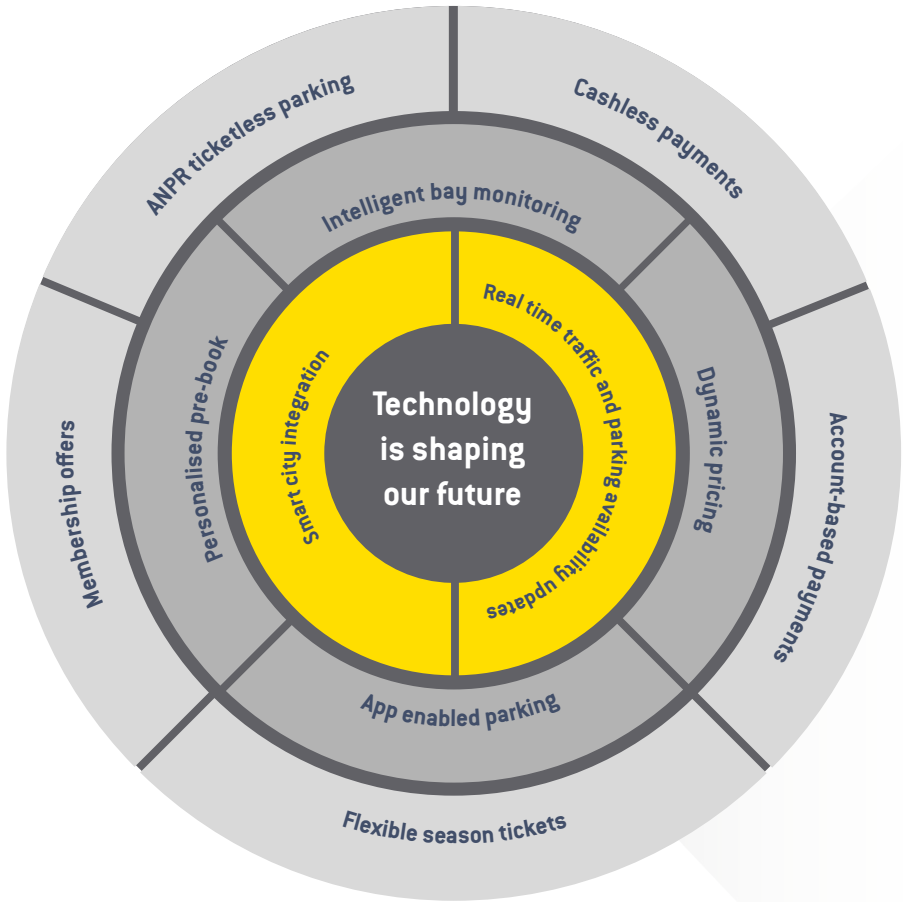
